

## **TERMS AND CONDITIONS**

This website is operated by Marketing Association Erasmus University Rotterdam (MAEUR). Throughout the site, the terms "we", "us" and "our" refer to Marketing Association Erasmus University Rotterdam. ### SECTION 3 - MEMBERSHIP (a) AND EVENT PARTICIPATION (b)

(a) A membership is open to all students studying at the Erasmus University Rotterdam. A membership is personal and cannot be transferred to another person. You are responsible for the password of your account on the MAEUR website, and you are not allowed to grant access to any third party under any circumstances. Membership fee costs € 12,50/year from August 1 − July 31st via automatic debt collection in January or May, depending on when you registered as a member. MAEUR remains the right to amend membership fees in the future. MAEUR will terminate your membership if requested by you. You can terminate your membership by sending an email to secretary@maeur.nl. Termination is confirmed when receiving a confirmation e-mail. Your membership will continue until July 31<sup>st</sup>, and will be terminated right after for the following year.

If you notify us that you wish to terminate your membership, you will remain a member until the 31st of July following your notification. This means you are still required to pay the membership fee for that year until the 31st of July. Your membership will be terminated from the following year onwards. Your data will be stored until the 31st of July following your notification unless you ask



us explicitly to delete your data before this date. If in our sole judgment you fail, or we suspect that you have failed, to comply with any term or provision of these Terms of Service, we also may terminate this agreement at any time without notice and you will remain liable for all amounts due up to and including the date of termination; and/or accordingly may deny you access to our Services (or any part thereof).

- (b) When applying for one of our events through our application form on our website, you agree with the following conditions:
  - (i) You are allowed and obliged to participate in the event once you are selected to participate and we successfully received your payment. You receive an automatic payment confirmation per e-mail.

This fee will be deducted from your bank account within 4 weeks after the event.
